Officer's Pay Voucher with black servants....

The 39th USCT was organized in Baltimore in March 1864 and was attached to the 1st Brigade, 4th Division, 9th Corps, Army of the Potomac to September 1864...service before Petersburg, the Siege of Petersburg, the Battle of the Crater, bombardment and assault on Fort Fisher...mustered out December 1865.

Pay voucher for 2nd Lt. Marvin Babcock (later promoted to Captain) for the period August 31st, 1864 to September 30th, 1864 and subsistance for his negro servant John H. Swowden. A rare voucher for a white officer of a black unit with a black servant.
